

TERMS AND CONDITIONS OF SALE CAMPING PARADIS LE TASTESOULE

INTRODUCTION

These Terms and Conditions of Sale apply to all services offered on the website « CAMPING PARADIS LE TASTESOULE » or any other means of communication.

The purpose of the website content is to inform clients. Some of the services offered may be subject to change depending on the occupancy rate and/or may only be available on certain dates during the season. Prices are provided for information purposes only and are subject to change and valid only for the current season. The service will be provided at the rate applicable on the date of the order. Prices include all taxes. Any change in the VAT rate will result in a change in the price. In accordance with the Tourism Code, « CAMPING PARADIS LE TASTESOULE » reserves the right to make changes to the information on the website or any other means of communication. Major changes will be communicated on the website as erratum.

1. BOOKING CONDITIONS

- Contracting parties must be at least 18 years of age and have the legal authority to contract and must not be under guardianship. The contracting party must be present for the entire duration of the stay
- Bookings are valid only upon agreement by the campsite, after receipt of the deposit and either the completed and signed booking contract or acceptance of the terms and conditions of sale when booking online.
- Camping pitch or rental bookings are made on a strictly personal basis. Under no circumstances may you sublet or transfer your booking without the prior consent of the campsite.
- Minors must be accompanied by their parents or legal guardians.

Camping Pitches

The basic package includes the pitch for a tent, trailer or camper for one or two people and access to the sanitary and reception facilities. Additional fees (extra person, pets, extra tent, etc...) are not included in the basic package rate and will be charged as add-ons. Camping pitches can accommodate up to six people maximum (baby included).

Rentals

Rental accommodations are equipped. The basic package is for two to eight people (baby included) depending on the type of rental.

« CAMPING PARADIS LE TASTESOULE » reserves the right to refuse access to the campsite to groups or families arriving with more guests than the capacity of the rented accommodation.

Booking fees

Booking fees are €20 for rentals and €10 for camping pitches.

2. RATES, TOURIST TAX & ECO-PARTICIPATION

- The listed prices are valid for the 2025 season. Prices are listed in euros, including VAT, and correspond to the chosen accommodation, number of people and duration of stay. Local taxes and optional add-ons are not included.
- A tourist tax, €0,81 per night and per person over 18 years of age, is collected for the City of VENSAC and payable to the campsite within 30 days before arrival.
- Our business is subject to taxes for use of natural resources (clean water) and waste treatment (waste water, household waste, etc.). We therefore charge compensation of €0.45/pers over the age of 5/night) to raise awareness for these expenses. This eco-participation is payable within 30 days before arrival.

3. PAYMENT CONDITIONS

- In a rental accommodation, for bookings made more than 30 days in advance, a deposit of 30% of the price of the reserved services is payable when booking. The balance is payable no later than 30 days before the arrival date.
- In a camping pitch, for bookings made more than 30 days in advance, a deposit of 30% of the price of the reserved services is payable when booking. The balance is payable no later than 30 days before the arrival date.

For reservations made less than 30 days in advance, the stay is payable in full when booking.

3.1 NON-COMPLIANCE WITH PAYMENT TERMS

In addition, the Service Provider reserves the right, in the event of non-compliance with the above payment terms, to suspend or cancel the provision of the Services ordered by the Customer and/or to suspend the performance of its obligations.

4. NO RIGHT OF WITHDRAWAL

In accordance with article L.221-28 of the consumer code, « CAMPING PARADIS LE TASTESOULE » informs its clients that the sale of accommodation services provided on a given date, or for a given frequency, is not subject to the 14-day withdrawal period.

5. PAYMENT

Accepted payment methods

You may honor your booking with the following payment methods, both for the deposit and balance:

Credit card, national or international bank transfer

Terms and conditions of payment

An official booking request by the buyer can be broken down as follows:

- 30% deposit + booking fees + cancellation insurance (optional)
- Balance at the latest 30 days before arrival for rentals and camping pitches. In the event that the balance is not paid within the time limits indicated, the booking is considered cancelled and our cancellation conditions described below apply.

By mail

An official booking request by the buyer can be broken down as follows:

- 30% deposit + booking fees + cancellation insurance (optional)
- Balance at the latest 30 days before arrival for rentals and camping pitches. In the event that the balance is not paid within the time limits indicated, the booking is considered cancelled andour cancellation conditions described below apply.

This reservation has contractual value only upon receipt by the purchaser of a booking confirmation issued by the campsite.

The balance of the stay is payable at the latest 30 days before arrival. In the event that the balance is not paid within the time limits indicated, the booking is considered cancelled and our cancellation conditions described below apply.

6. CANCELLATIONS AND CHANGES

Changing your booking

- The Client may request a change to their stay at the same campsite (dates, type of accommodation). Without prejudice to the fact that the balance is payable in full before departure, any changes at the request of the client may incur change fees. All change requests must be confirmed in writing by the client and are subject to availability and acceptance by « CAMPING PARADIS LE TASTESOULE ». In the event that the contractor wishes to extend their stay, the current rate will apply. Any changes made from higherrange to lower range services will not incur a refund.
- Any request to reduce the length of your stay is considered a partial cancellation and will be subject to the cancellation and interruption of stay conditions.
- Any request by the CLIENT to change or cancel their STAY must be sent to « CAMPING PARADIS LE TASTESOULE » by registered letter with acknowledgement of receipt.
 Thetime limits indicated below are from the date on which the letter is received, as evidenced by the postmark. Cancellation or changes to the STAY will incur at minimum the following fees:
- * More than 30 days before the beginning of the STAY: 30% of the total cost + processing fees + insurance fees (if taken out)
- * Less than 30 days before the beginning of the STAY: 100% of the total cost + processing fees + insurance fees (if taken out).

Unused services

Any interrupted or shortened stay (late arrival, early departure) or failure to appear at the campsite for a reserved accommodation will not incur a refund.

Change or cancellation by « CAMPING PARADIS LE TASTESOULE » campsite

If « CAMPING PARADIS LE TASTESOULE » cancels your stay, except in cases of force majeure, the Campsite will inform the Client as soon as possible by email.

The Campsite will do the best to propose a solution to the Client.

If the Client does not agree, the entire cost of the stay will be refunded. However, you may not receive payment of damages.

Cancellation Insurance

For your peace of mind, we advise you to subscribe to the cancellation insurance of the campsite to benefit from a refund up to 70% of the amount paid in case of cancellation of your stay, even without proof.

Without any subscribe to this insurance, no refund can be made by the campsite.

7. YOUR TRIP

Arrival

- Camping pitches: arrivals are form 3:30 pm, onwards
- Rental accommodations: you may check in starting at 3:30 p.m. on your day of arrival, and a security deposit is required when you receive the keys to the rental

During your stay

The campsite declines all responsibility in the event of an incident falling under the civil responsibility of the camper. All clients must comply with campsite rules. Guests are responsible forany disturbances caused by persons staying with or visiting them.

The Client must hold valid civil liability insurance covering their personal belongings, as well as any damage they may cause to third parties, to the equipment or facilities of the Campsite, including the rented accommodation. This insurance must guarantee compensation for any loss or damage that may occur during the stay. The Client must be able to provide, at any time and upon simple request from the Campsite, a valid certificate of civil liability insurance. Failing this, the Campsite reserves the right to refuse access or to terminate the stay without compensation.

Departure

Rental accommodations

- On the day of departure indicated on your contract, the rental accommodation must be vacated before 10:00 a.m. The accommodation must be returned in a perfect state of cleanliness, the inventory may be verified, any broken or damaged object will be at your expense, as well as any repairs to the accommodation that may be necessary.
- Your deposit will be returned few days after the end of your stay, after deduction of any fees incurred, with invoices provided, for any damage found at the exit inventory. Non repayment of the deposit does not preclude payment of additional compensation in the event that the costs exceed the amount of the deposit.
- If the accommodation has not been cleaned before your departure, a minimum cleaning fee of €120 including tax will be charged.
- For any late departure, you may be charged an extra day at the current nightly rate.

Camping pitch

- On the day of departure indicated on your contract, the camping pitch must be vacated before 2.00 pm. The camping pitch must be returned in a perfect state of cleanliness.
- Your deposit for the token of your pitch will be returned straight away after dropping it to the reception.

8. INTERNAL REGULATIONS

The rules and regulations are posted at the entrance to the establishment and at the reception desk. The Client is required to read and respect these rules.

9. VISITORS

Visitors are admitted to the campsite after checking in at reception and paying the visitor's fee. Visitors will have access to the campsite's facilities.

10. PETS

Dogs allowed under request only. Not more than 1 dog (even a small one).

«Dogs less than 20kg are allowed only under request at booking and subjected to send a copy the recording book including race, weight, id number and up-to date rabies.

The campsite does not accept species classified as dangerous or defensive under the law relating to dangerous dogs such as: Pit Bull Terrier, Japanese Tosa, Argentine Dogue, Fila Brasileiro, Staffordshire Bull Terrier, American Staffordshire Terrier, Rottweiler, any Mastiff or Tosa species, or any other similar breed, whether or not registered with the LOF."

The campsite reserves the rights to refuse any dogs he judges dangerous for its clients or who does not meet the required conditions.

Dogs must be kept on leash all the time and must not be left alone on the pitch or in the accomodation.

They are prohibited around the swimming pool, in the grocery and in the buildings.»

11. IMAGE RELEASE

You expressly authorize « CAMPING PARADIS LE TASTESOULE » to use photographs and/or videos that may be taken during your stay for the communication needs of the Camping Paradis group.

Any guest refusing to be photographed or filmed during their stay must inform « CAMPING PARADIS LE TASTESOULE » in advance and in writing. You also authorize distribution, publicationand marketing of these images and videos on all types of media.

12. DISPUTES

- Any complaints regarding non-conformity of the services provided with contractual commitments can be reported by sending a letter by registered mail with acknowledgement of receipt to Camping Le Tastesoule 2 Route des Grigots 33590 Vensac no later than twenty (20) days after the end of the stay or by email to reservationtastesoule@gmail.com.
- Moreover, any complaint regarding non-conformity of services provided with contractual commitments found during pointed out during the stay must be pointed out to the reception within 24 hours, and a written confirmation has to be sent to reservationtastesoule@gmail.com of by letter by registered mail with acknowledgement of receipt to Camping Le Tastesoule 2 Route des Grigots 33590 Vensac.

13. MEDIATION

In accordance with the French law of January 6, 1978, you have the right to access, rectify, and oppose any personal data concerning you.
